



# LIMITED WARRANTY

## WELCOME

Dear customer, congratulation on your choice for a board of the CrazyFly. We hope you will be satisfied with our product and have a lot of fun in wind and waves.

**Please fill out your warranty card and get it stamped by your dealer.**

We guarantee the customer of this board the warranty conditions as described below. Duration of warranty is 12 months since date of purchase. This warranty commitment does not cover any other claim condition that is beyond our warranty limit and which was guaranteed on the basis of a purchasing contract with the dealer. This board is warranted to the original owner against defects in workmanship or materials. The guarantee applies only to the first case of guarantee. If a believed claim defect or damage is detected, the board must be immediately returned to the dealer for inspection. The dealer will make the first decision as to whether it is a case covered by the guarantee or not. We reserve the final right to decide on the type of guarantee granted, whether repair, reduction in price or replacement. If replacement, board is always replaced for new one without accessories (if not agreed otherwise).

## THE FOLLOWING IS EXCLUDED FROM THE GUARANTEE:

1. damage or defects caused by impact on, to or with any material
2. damage caused by intention, gross negligence, improper handling, non-observance of operating instructions, insufficient care and maintenance
3. defect or damage caused by jumping, acrobatics, collisions, abuse, misuse or accidental damage
4. changes caused by normal wear and tear
5. a board used after a defect or damage appears
6. faults which had led to a classification of the product as second grade
7. products the purchase of which is not proved
8. damage caused by transport, loading, unloading, dropping, handling out of water or similar
9. damage or defects caused by exposure to temperature over 70 and under 0 degrees Celsius
10. defects or damage caused by nature forces (such as earthquakes, fires etc..)
11. defects or damage caused by modifying the board in any way
12. boards which have been repaired and later show damage or defect. Repairs will be accepted only if:
  - a) materials used for repair are compatible with the materials used in the original construction of the board.
  - b) repairs are done properly by qualified personnel.
  - c) repairs have no connection and show no results to be reason for damage and/or defect to develop.

Board must stay in shop till receiving this answer.
